Furthermore, I hereby agree to indemnify, hold harmless and defend the City of Grand Prairie, its officers, agents, and employees, from any and all suits, for property loss or damage and/or personal injury, including death, sustained by others by reason of my child's participating in the City of Grand Prairie volunteer program.**

I certify that I have read this release thoroughly, that I understand its terms and conditions, and that I make this release and waiver voluntarily and have not relied upon any representations made by the City of Grand Prairie, its officers, agents, employees or volunteers. I further certify that I understand that in making this waiver of liability I am making a decision of substantial significance and am willing to assume such risks.
